1. High Impact Tutoring Program

Dr. Boryszewski shared with the Board about applying and being awarded a grant

from ISBE which enables the District to offer a High Impact Tutoring Program. She further shared that on January 23rd, 2023, 138 students from across all three of the District 81 Schools will partake in Reading and Math tutoring twice a week. The district hopes this program will help to close the Covid achievement gap.

2. Ukraine / Russia Refugees

The Superintendent informed the Board of Education about the fact that District 81 currently supports 46 refugee students from the Ukraine / Russia impacted conflict.
